**Qualifications**

- Must have full insurance coverage with a \$500 deductible by the time of transfer.
- Must not have a current felony, DWI, DUI, or a car with existing, restricted plates (whisky plates)
- A charitable lien will be placed on the vehicle for the term of one year. If that if the vehicle is impounded for any reason, BTG would have the right to repossess the vehicle, and the recipient forfeits the vehicle. After one year provided proof of insurance is valid, the charitable lien will be released.

**Disclaimer:**

Bridging the Gap (BTG) will not provide updates on application statuses nor publish or publicly announce the recipient of a BTG vehicle giveaway. If selected to receive a vehicle, you will be notified by a Bridging a Gap (BTG) representative and be requested for a phone interview to verify your application information and to schedule a meeting to transfer the vehicle title at the DMV nearest to the vehicle’s current location.

By submitting this application, I hereby permit BTG to perform a background check, as deemed appropriate, as well as to utilize any information (other than personal contact information or my photo) without my consent—or any compensation—as it deems applicable, including for public, promotional purposes.

Should I be named as the vehicle giveaway recipient, I agree to be able to make an appointment (along with having a companion, who holds a valid driver’s license, accompany me) with a BTG representative to transfer the vehicle title during normal business hours at the DMV closest to the vehicle’s location within two weeks of the Single Moms Retreat. Failure to make such an appointment would result in the vehicle being given to another recipient.

By signing this application, I verify my ability to cover the cost of transferring a vehicle, including vehicle tax and transfer fees. I also verify that I have a valid and unrestricted driver’s license, am able to financially afford the cost of owning this vehicle, including to pay the required monthly insurance

premium (as listed in the insurance binder I have provided), required annual tabs, taxes, and fees, and fuel, as needed. I also agree that I am in full and right standing with the “qualifications section” within this application.

Should my application be chosen, I am willing to accept this vehicle and acknowledge that Bridging the Gap is not liable for any fees, vehicle maintenance, fuel, potential injury, or any potential incidences related to me or this vehicle before or after transferring the title.
